Family Promise of Grayson County (FPGC) received a second manufactured home from Clayton Homes. This doubled our capacity to provide transitional housing to families needing more time to attain their financial goals.

FPGC continued its financial literacy program and Tool Talk home maintenance and repair classes. We also hosted a health class led by the Callie Clinic. We are grateful to them, our volunteers, and partner financial institutions for so generously sharing their knowledge and time.

Through our Blessing Box, we made available food, hygiene products, cleaning supplies, blankets, and clothing. This was used throughout the year, often multiple times a day, by neighbors and others in the community.

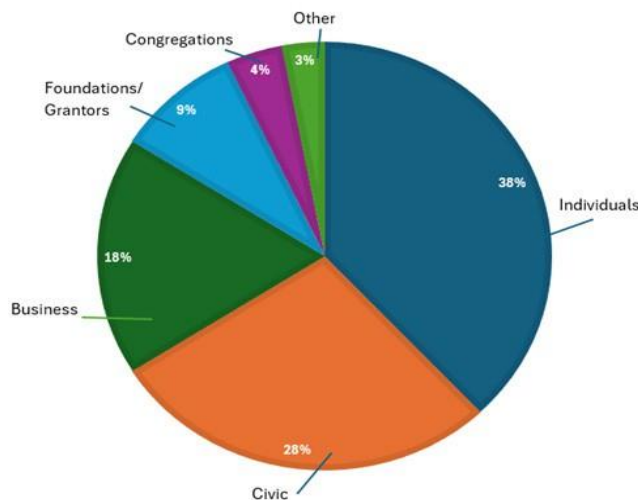
